Privacy Statement

Terms of Delivery for ronaldjan.com and all of its related Brands.

Article 1 - General

1.1 These terms of delivery apply to all offers, assignments, and agreements between ronaldjan.com (hereinafter referred to as “ronaldjan.com”) and its clients (hereinafter referred to as “Client”).

1.2 Deviations from these terms are only binding if agreed upon in writing.

Article 2 - Offers and Ideas

2.1 All offers and quotations provided by ronaldjan.com are non-binding and remain valid for 30 days unless stated otherwise in writing.

2.2 As part of the offer, ronaldjan.com may present ideas, sketches, designs, or other creative proposals (hereinafter referred to as “Proposals”) to the Client. These Proposals remain the property of ronaldjan.com and may not be used, copied, shared, or modified without prior written consent.

Article 3 - Intellectual Property

3.1 All intellectual property rights for designs, concepts, proposals, documents, or other works (hereinafter referred to as “Creations”) developed by ronaldjan.com belong exclusively to ronaldjan.com, unless agreed otherwise in writing.

3.2 Ronaldjan.com grants the Client a limited, non-exclusive right to use the agreed-upon Creations for the intended purposes only after full payment of the invoice.

3.3 If a Proposal is rejected by the Client or does not lead to an assignment, ronaldjan.com is entitled to freely use or modify these Creations and ideas for other clients.

3.4 The Client is not permitted to edit or have the Creations edited by third parties without prior written consent from ronaldjan.com.

Article 4 - Confidentiality

4.1 Both parties are obligated to maintain the confidentiality of all information exchanged in connection with the agreement. Ronaldjan.com’s Proposals and Creations fall under this confidentiality obligation.

4.2 The confidentiality obligation remains in effect after the agreement has ended.

Article 5 - Delivery and Liability

5.1 Ronaldjan.com undertakes to execute the assignment carefully and professionally. Delivery deadlines are indicative unless otherwise agreed in writing.

5.2 Ronaldjan.com is not liable for damages resulting from the improper use of the delivered Creations by the Client.

Article 6 - Payment

6.1 Payment must be made within 14 days of the invoice date unless otherwise agreed.

6.2 If the payment term is exceeded, the Client is in default without further notice and ronaldjan.com is entitled to charge statutory interest and collection costs.

6.3 In the improbable situation where ronaldjan.com is requested to deliver a new product idea but the Client does not accept its work result, ronaldjan.com will charge a symbolic fee of EUR 795,- excluding VAT to compensate for the efforts that were made plus incurred costs.

Article 7 - Termination

7.1 Ronaldjan.com has the right to terminate the agreement if the Client fails to fulfill essential obligations, such as payment or adherence to confidentiality requirements.
